Policy Updates

Moving ahead on the EU Heat Strategy

The summer may slow down Brussels' policy engines, but that is not the case for heating and cooling. One topic of high interest for our sector took a next important step: the preparations for the upcoming "Heat Strategy". The European Commission launched in mid-July the invitation for a stakeholder consultation forum on the future Strategy, to take place in Brussels on 9 September. The Secretariat together with the Energy Policy Committee are coordinating Euroheat & Power's contribution and participation in this consultation. The documents prepared by the Commission ahead of the consultation meeting are available here.

Following this meeting, the Commission is expected to prepare the Communication on an EU Heating and Cooling Strategy, accompanied by a more detailed comprehensive analysis of the sector, to be released before the end of 2015.

According to the <u>policy initiative Roadmap</u> published by the Commission, the upcoming Strategy is aimed at informing and providing inputs in the context of future legislative reviews and proposals having an impact on the supply and use of heating and cooling, in particular those related to the Energy Efficiency Directive, the Energy Performance of Buildings Directive and the Renewable Energy Directive, as well as assessing the role and contribution of our sector in achieving the EU energy and climate goals.


