Policy Updates

One year of Energy Union

On 25 February, the Energy Union celebrated its first anniversary. According to the European Commission, much has already happened in the quest to make Energy Union a reality and 2016 is set to continue to be a year of delivery. Earlier in February, the Commission launched its '[security of supply package](#)' including our very first [strategy on heating and cooling](#).

In the second half of this year will come a review of the [Energy Efficiency Directive](#) and the [Energy Performance of Buildings Directive](#). In autumn the second State of the Energy Union will look at how far Energy Union has come in 2016 and how far it must travel to achieve its targets. And towards the end of this year, we expect a proposal on electricity market design and the revision of the security of supply for electricity regulation. The [Renewable Energy Directive](#) will also be revised, and a bioenergy sustainability policy for 2030 set up.

Euroheat & Power position on EU ETS

At its 29 February meeting the Energy Policy Committee endorsed an amended [Euroheat & Power's position paper on the revision of the EU ETS](#). The position includes amendments to the Commission's legislative proposal, which the Secretariat will promote among the EU decision-makers in Brussels. The Parliament's rapporteur Ian Duncan (UK Conservative) charged with preparing the Parliament's position on this dossier is now expected to present a draft of his report in May. The deadline for amendments to his report is 21 June and the vote in the parliamentary Environment Committee, which has a leading role in preparing the parliamentary position on this dossier, is expected on 8 December. The EU institutions are expected to finalise the negotiations on this dossier under the UK Presidency by the end of 2017.

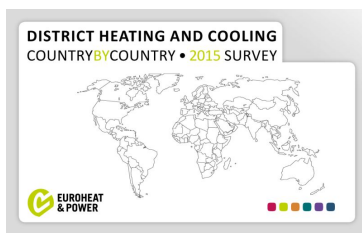

DHC+ Updates

STRATEGO presented to EU stakeholders

On 29 February, the STRATEGO project was presented to the key EU policy stakeholders during an Information meeting organised by [ICLEI Europe](#) in Brussels. Representatives of the European Commission DG REGIO and the EU Committee of the Regions were curious to hear about the background of the project from its coordinator Alessandro Provaggi (DHC+) and to see some evidence to support national heating and cooling policies presented by David Connolly (Aalborg University). Three days later, Dana Popp (Euroheat & Power) was invited to present the project results and its link to the EU Heating and Cooling Strategy at the [EFIEES](#) meeting. The European Federation of Intelligent Energy Efficiency Services has recently joined the STRATEGO European Advisory group in order to be informed about the progress of the project and to be able to provide feedback and recommendations.

New project launched: 'SDHp2m... from policy to market'

The kick-off meeting of the Horizon 2020 project SDHp2m took place on 22-23 February in Erfurt, Germany. It was hosted by the Thuringian Ministry for Environment, Energy and Nature Conservation which is also partner in the project. The SDHp2m project aims at developing, improving and implementing advanced policies and support measures for Solar District Heating, leading to a significant market roll-out during its three year duration. This first meeting marked the starting point of an intense cooperation between the EU regions involved and the exchange was very fruitful. It clearly appeared in previous SDH projects that it is really important for stakeholders to learn about already realised activities in the field and to have peer-to-peer contacts before making decisions. This European project creates the framework for such opportunities that are planned all along the project duration.
